A Village:

- ▶ Of some 2500 - 400% larger than in the 1950's
- ▶ Halfway between Reading and Wallingford
- ▶ Entirely within the Chilterns AONB
- ▶ With some Victorian, but mostly undistinguished 1960/70's, houses
- ▶ In which:
 - most work outside the village;
 - fewer than half of those employed locally live in the village;



Woodcote Rally

An active community

EARLY LESSONS



In the beginning.....

- ❖ Have a clear sense of desired outcomes
- ❖ Get a road map early
- ❖ Get a budget together
- ❖ Create and implement a communication plan
- ❖ Get a community mandate
- ❖ Identify an engaging entry point
- ❖ Proceed in small steps
 - ⇒ build community engagement ;
 - ⇒ grow buy-in and learning; and
 - ⇒ learn
- ❖ Ask others

as you go

EARLY LESSONS



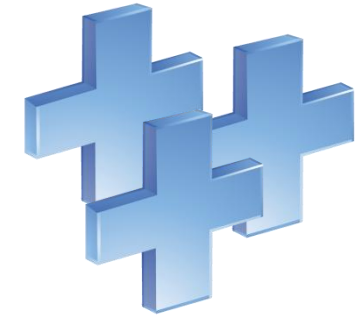
Remember

- ❖ The Examination - document evidence as you go along
- ❖ The Referendum – consult and communicate continuously
- ❖ The Sustainability Appraisal – sort it early!!
- ❖ To watch for ‘Scope Creep and ‘hijackers’
- ❖ It’s a community plan – not yours!

- ❖ Interference and attack
- ❖ Frenzy
